For licences to keep birds, the Department will require details of membership of a relevant organisation or the names of two referees who will vouch for your ability. This applies to the following types of licence:-

- Licence to hold birds of prey for falconry.
- Licence to hold birds for aviculture (details of your outdoor aviary are also required for this licence).

Licences to kill any protected species must carry the full name of the person so licensed. Please give the name(s) of persons who will kill birds.

3. Fees. Licence fees are as follows:-

BPL	- To hold a captive bred bird of prey	£10.00
BPC	- To breed birds of prey in captivity	£50.00
VRO	- To hold wild birds for aviculture	£10.00
BPD	- To exhibit birds of prey	£50.00
XYO	- To sell dead wild birds and animals (taxidermy)	£50.00
